## DEFENDANTS' UNOPPOSED MOTION FOR EXTENSION OF TIME TO RESPOND TO LAS AMERICAS PLAINTIFFS' COMPLAINT

Defendants Steven C. McCraw, in his official capacity as Director of Texas Department of Public Safety; and Bill D. Hicks, in his official capacity as District Attorney for the 34th Judicial District of Texas, respectfully request a thirty-day extension to respond to the Complaint of Plaintiffs Las Americas Immigrant Advocacy Center, American Gateways, and the County of El Paso in Case No. 1:23-cv-1537, which would otherwise be due April 1, 2024 (per Text Order entered on January 22, 2024 in Case No. 1:23-cv-1537). Defendants have conferred with Plaintiffs concerning this motion, and it is unopposed.

Good cause exists for an extension. Currently, the grant of a preliminary injunction by this Court has been appealed, with proceedings currently ongoing in the U.S. Court of Appeals for the Fifth Circuit. ECF No. 49. Accordingly, extending the time for Defendants to respond to the Plaintiffs' Complaint by thirty days will conserve the parties' and the Court's resources. A proposed order is attached.
